Chemraz® SD625 is permitted for use in the fabrication of molded parts (including a-rings, gaskets, diaphragms and other materials that function primarily as components of sealing applications) for food processing equipment in accordance with the United States Food and Drug Administration (FDA) **Food Contact Notification (FCN) 245.**¹

In accordance with the requirements set forth under FCN 245, **Chemraz® SD625** also meets the extractive limitations prescribed in 21 C.F.R. Section 177.2400 ("Perfluorocarbon cured elastomers"), paragraph (d).²

Chemraz® SD625 has been tested in accordance with United States Pharmacopeia (USP) Standards for use in pharmaceutical applications. More specifically, **Chemraz® SD625** has been evaluated under USP <87> ("Biological Reactivity Tests, *In Vitro*") and USP <88> ("Biological Reactivity Tests, *In Vivo*") and meets applicable requirements for Class VI polymers.³

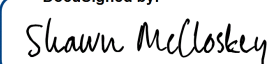

The material is covered by the scope and applicable definitions in these standards. The material complies with the applicable material and compatibility criteria found in sections C and D for a Rubber Class I material.⁴
